Fred Baker moved, and Henk Uijterwaal seconded a motion to accept the minutes for 14 January 2010. There were no corrections or objections. The motion passed unanimously.

1. BSD License

Ray Pelletier indicated that a couple of questions have arisen regarding the BSD License. These questions are:

- A. Do we need the BSD license for Code Components as currently required by TLP 4.0 for the IETF Stream?

- B. "Simplified" BSD - is that the correct version?

Ray distributed a document that consolidated a number of comments and questions related to whether there needs to be a BSD license for Code Components that have been raised on the mailing list. It was noted that the Alternate Streams have no BSD License requirement. Instead these streams simply require proper attribution. He provided an overview of this document. Russ Housley pointed out that the IETF Trust does not need to address the second question because the answer to the first one takes precedence. Marshall thinks the second question is a nit that we can fix next

time around.

The bottom line consensus was that there is nothing to do regarding the first question at this time. We are nowhere close to done with the TPL. Marshall Eubanks indicated that this isn't an emergency fix type of issue. Bob Hinden remarked that making any change like this requires broader community review. Russ Housley stated that we shouldn't make a change like this without an RFC directing us to make that change.

2. Virtual T-Shirt License
