1. IETF Logo Use

Marshall Eubanks called the IETF Trust meeting to order at 14:05 UTC and noted the

presence of a quorum.

## 0. Minutes

The first agenda item was to approve minutes for the Trust meeting on 2010-04-08. Henk Uijterwaal moved and Marshall Eubanks seconded a motion to approve the minutes subject to modifications outlined on the mailing list. There were no objections, and the motion passed.

## 1. IETF Logo Use

The next item on the agenda was the use of the IETF Logo. Olaf Kolkman joined the meeting. Ray Pelletier reminded everyone of the text in the IETF Trust FAQ for the use of the IETF acronym and logo:

### 4. What usage is OK without a license?

The acronym "IETF" may be used factually in any on-line or traditional publication, in presentations and documents, and in press and media reports, as a descriptive term for the Internet Engineering Task Force.

The same applies to other phrases such as "IETF Secretariat", "IETF Trust", "IETF Standard" or "IETF RFC".

The IETF logo may be used, without modification, to accompany descriptive text to refer specifically to the IETF organization itself or its work. The logo must be reproduced in the exact format, scale and colors displayed at <http://www.ietf.org/images/logos/>.

Neither the IETF name nor logo alone or in combination with other words may be used to claim support or endorsement for, or as an indication of origin of, any goods or services.

Jorge Contreras outlined some issues with respect to the logo. The name "IETF" is a registered trademark in many countries. The four-diamond logo has been registered only in the US. Marshall Eubanks asked whether common law protections extended to the trademark in the EU, and Jorge Contreras said they do not because they are mostly not common law countries.

Jorge Contreras noted that it is always lawful to use a trademarked word like the acronym "IETF" in a factual reference. The case of a logo is more complicated, but the Trustees have previously determined it better to permit the logo in such contexts too. There is a question whether the use of the logo in contexts that are more than mere references, or where some endorsement seems implied, are acceptable.

Ray Pelletier asked about a particular case where the IETF logo is modified: is the problem not just the issue of a derivative work?

Lynn St. Amour joined the meeting.

Marshall Eubanks asked for a straw poll as to whether the current FAQ text might be left as it is.
