#### 1. Minutes

The meeting minutes have been reviewed. Scott made the motion to approve the minutes and Tobias seconded the motion. The minutes were approved without further discussion or objection. Leslie abstained.

## 2. IANA Domain and Trademark Opinion

Ray stated that in accordance with the Administrative Procedures of the IETF Trust motions passed by electronic means between meetings by the trustees shall be confirmed by a vote.

Upon the request of the IETF Trust Chair on 19 February 2015 an official e-vote was called on the following question:

Are you willing for the IETF Trust to make the following statement?

In accordance with Article 5.2 of the Trust Agreement the IETF Trust would be willing to hold intellectual property rights relating to the IANA function, including the IANA trademark and the IANA.ORG domain name.

Background:

In response to the question from the ICG to the IANAPLAN WG the IETF Chair on 17 February 2015 has asked the IETF Trust its opinion on whether it would be willing to hold intellectual property rights relating to the IANA function, including the IANA trademark and the IANA.ORG domain name.

The IANAPLAN WG was asked by the ICG on 9 February 2015:

"With regards to the IANA trademark and the IANA.ORG domain, it is the expectation of the Internet Number Community that both are associated with the IANA Numbering Services and not with a particular IANA Numbering Services Operator. Identifying an organization that is not the IANA Numbering Services Operator and which will permanently hold these assets will facilitate a smooth transition should another operator (or operators) be selected in the future. It is the preference of the Internet Number Community that the IANA trademark and the IANA.ORG domain name be transferred to an entity independent of the IANA Numbering Services Operator, in order to ensure that these assets are used in a non-discriminatory manner for the benefit of the entire community. From the Internet Number Community's perspective, the IETF Trust would be an acceptable candidate for this role."

Article 5.2 Contribution or License of Other Property of the Trust Agreement says: The Trustees will encourage others who may hold rights and interests in intellectual property, domain names or other property relevant to the IETF to similarly transfer all of their respective right, title and interest therein to the Trust, including by licensing to the Trust (preferably on a perpetual, irrevocable, worldwide, royalty-free basis), with the right to sublicense, rights to practice their inventions and patents, which the Trust may use and license to third parties in accordance with Section 9.5 of this Agreement; provided, however, that no contribution, transfer, or license of such rights or interests shall be deemed accepted as part of the Trust Assets unless the Trustees have affirmatively, in writing, accepted the applicable right or interest.
